Asset Preservation

With capital replacement budgets declining, it is your responsibility to preserve the assets under your management longer than you have been asked to in the past. Asset preservation runs the gamut from regular and preventive maintenance to remodeling and reconstruction. While replacement schedules are being extended, it is also important to dispose of assets when they've exceeded their useful life.

Since 1989, more than 7,000 airport operations personnel have attended one or more of these schools. ASOS schools have become a regular and recurring part of virtually every airport's training program for operations staff. Endorsed and taught by FAA officials and other airport industry professionals, these nationally recognized courses are designed to increase awareness of FAA's Part 139 airport certification program, as well as to enhance the professionalism and safety responsibilities of airport operations personnel. These professional schools are specifically tailored to airport personnel responsible for the day-to-day operations of public-use (both commercial service and general aviation) and military shared-use airports throughout the United States. These professional schools also are tailored for airport personnel responsible for conducting and maintaining the self-inspection programs of public-use and military shared-use airfields throughout the United States. These schools also provide an excellent networking platform for airport operators to meet and exchange ideas to continue to make our airports safe and operationally efficient.

The Advanced ASOS school will outline how airports can continue to take proactive steps to prepare to implement new safety management practices and clarify any issues. The faculty will include FAA regional personnel, officials from the airport community, airline pilots and others knowledgeable about airport operations and safety matters. This school is one of several options available to airport operators to comply with 139.303 (c-e).

All sessions will take place at the Grove Hotel. Sessions will begin at 8 a.m. on Tuesday, August 3 (registration and continental breakfast begin at 7:30 a.m.) and end at 4:30 p.m. on Wednesday, August 4.
